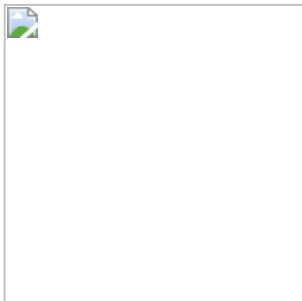

When that doesn't happen, it goes to the Prosecutors office.

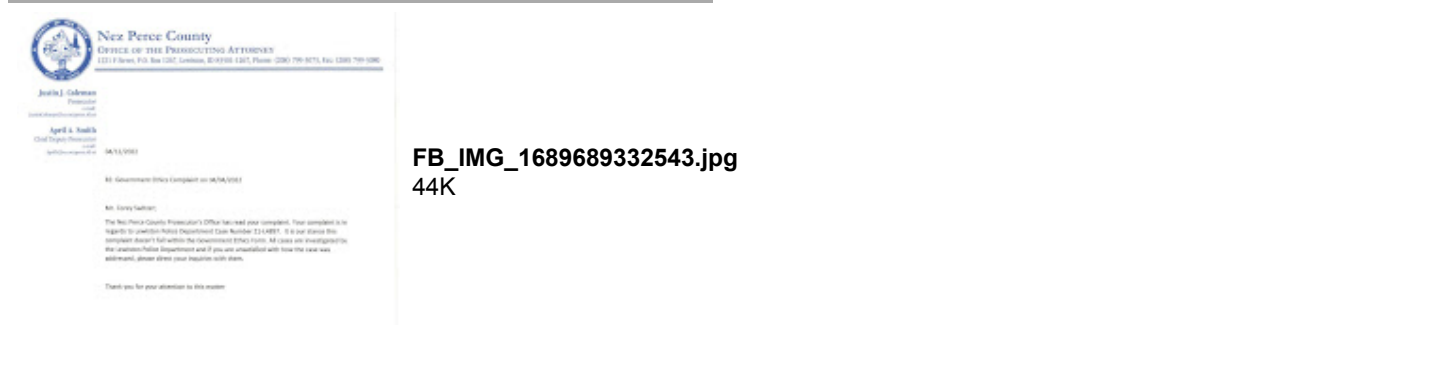
When THAT doesn't happen, it falls squarely on the mayor's desk.

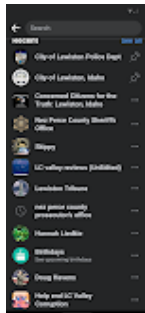

We can start with Andrew Fox, Ofc Lines, and Nick Woods accepting substantial financial donations while in police uniform at Travelland RV in August, September, and October of 2020 from Kevin Munstermann, Meghan McCreary, Tim Kruger in addition to weekly telephone calls requesting financial donations.

When the felonies were filed against Troy Munstermann, for battery, with Jason Lines, and then Jeff Klone in April of 2021, they did not forward the CAPS sheet to the Nez Perce Prosecutors department. Despite many attempts by the Victims Advocate Joyce Kaufman to contact Jeff Klone to tell him to turn over the CAPS sheet, Jeff Klone refused and stated the Nez Perce Prosecutors department was responsible for not picking up the charges, when the Nez Perce County prosecutors office COULD'T pick up the charges for crimes which weren't sent. Additionally, I learned that the financial crimes by Meghan McCreary, who changed her name after being discovered for these same financial crimes to Vittoria Paxe Puccini.

It was in December of 2021 that I began demanding an ethics investigation into Troy Munstermann to find in April of 2022, Meghan McCreary's financial crimes weren't even assigned a case number. Once more I filed a case with the City of Lewiston PD, and was assigned Andrew Fox, the officer and President of the Fraternal order of Police, who said my claims were unfounded.

I have clearly provided you and your city workers with the financial crimes of which I speak.

When I filed an ethics investigation into Nez Perce County Prosecutors office for the lack of charges against those who violated my rights, I was forwarded to Budd Hurd of the City Of Lewiston Police Department for an ethics investigation. Budd Hurd then promoted the person being investigated to the Chief of Police and to handle Jeff Klones own investigation. No further investigation was done, to nobody's surprise.

To then retaliate by turning off the cities social media comments or blocking me entirely in excess of one year of demanding these ethics investigations is not only a further ethics violation, it's a violation of the first amendment of our constitution.

The city blames the county for not picking up the charges which the county blames the city for never sending over to be picked up in the first place and I'm being blamed for saying the truth. While ignoring people may be a tried and true strategy for making problems disappear, this won't be the case here.

Of course, Budd Hurd refusing to do the ethics investigation himself is an entirely separate issue than appointing the Jeff Klone to investigate himself.

In addition to all of that, the city police also employed Travelland RV to repair and supply trailers for the police department sting operations.

At no point has anyone given me a clear and consistent answer as to why these multiple felonies were ignored, but the clear violation of a lack of proper investigation, reporting, and filing on behalf of the LPD in excess of 16 months by two different police chiefs is yet another ethics violation.

In fact, reporting these crimes committed by Troy and Meghan has had the result of being blocked by city and county departments violating my First, Fifth and Fourteenth constitutional amendment rights rather than addressing the issue head first.

No, sir. I shall not be quiet. I shall not be going away.

This city will be making a public statement regarding these ethics violations or they will be seeing me until the end of time.
