On April 13, 2022 I took her phone report of suspicious circumstances. I was able to make phone contact with Cory Switzer in reference to a possible battery that happened in March 2021 at his place of employment, Traveland RV in Lewiston. Cory was also advising that his identity was possibly taken by the company and being used fraudulently. Corey advised me he was recording our conversation and would not tell me where he was located.

Cory advised that he had already been in contact with Ofc. lines and Capt. Klone reference these issues. See case 21-L4897. Cory appeared to be upset that the resolution of this case was designated to be a civil issue by the Nez Perce County prosecutor's office.

I advised Cory I would attempt to follow up and find some information for him. I contacted Cpt. Klone and Cpt. Fuentes about the issue. I was advised by both captains that this had been resolved and there was no need for any follow-up investigation.

When I returned to duty on April 17, 2022 I had received roughly 30 emails from Cory. These emails contained information accusing Traveland RV of tax evasion and fraud. After contacting the Nez Perce County prosecutor's office and looking at the documentation, no fraud or tax evasion had occurred. I advised Cory he needed to contact the Idaho tax commission for any further assistance. Cory advised that he thought he was being harassed by Traveland RV and cited federal codes that he would like them charged with. I advised Cory that under Idaho code there would be no charges available for the harassment and he would need to contact the FBI to enforce federal code and jurisdiction.

This ended my contact at this time. My Axon body camera was active for my investigation and has been added to the case file.
