On 01/08/2024, I made phone contact with Corey Switzer reference a report of harassment. Corey stated that City Council member Jessica Klein was harassing him on Facebook and he wanted to press criminal charges for libel and slander.

I spoke with Corey who advised the following: a couple days ago Jessica blocked him on Facebook. She made a Facebook post stating that she blocked him out of fear for her safety as he had made threats against her family or people close to her.

Corey stated this post was incorrect as he had never made any kind of threatening statements towards her. He stated he was requesting Jessica open an investigation into the Police Department per her position on City Council.

Corey stated he advised Jessica she could not block him on social media as she is a public figure holding an elected office. Since then, she has unblocked him from Facebook. Corey stated he had screenshots of the posts that he would send to dispatch to prove they were libel and slander.

I advised Corey that a necessary component of proving libel is to prove the poster had direct knowledge that their statements were false. I advised him that Jessica may have felt threatened and therefore made this post, and that her post was protected under freedom of speech.

Corey then began quoting Idaho code to me. He was upset that I would not pursue criminal charges in this matter. I advised him that if he could prove any damages from at Jessica's statement, he may be able to pursue a civil case in this matter.

I provided Corey with the case number for this incident. My body camera footage has been retained as evidence.

I have nothing further to report at this time.
