Narrative:

Investigative Narrative
BCW-YES

On July 26th 2023, I was working Patrol for the Clarkston Police Department. At approximately 1230 hours, I came into contact with Trae Turner at the Police Station. Trae is an attorney from Lewiston, and with him was Vittoria Puccini. It was at that time Trae and Vittoria provided the following information;

Vittoria explained that she had a dating relationship with Corey Switzer. They dated from Sept 2018 to October of 2019. Sometime during this relationship, several Intimate images had been taken by Corey during sexual intercourse. Corey now has spread them through social media, specifically the Nez Pierce County Face Book Page, for the public to see. These photos were obtained under circumstances in which a reasonable person would know and understand that the images were to remain private. Corey did know or should have known that the images were to remain private, and there was absolutely no consent given to him by Vittoria to spread the photos. Corey also started sending Vittoria's boyfriend private and explicit photos of him and Vittoria, and continues to, "Stalk" Vittoria on social media. Vittoria stated this treatment has been on-going and felt it was time to bring it to the attention of Trae. Trae also explained he too received a picture of Corey's erect penis with a message, "I'm coming for you next". Vittoria completed a voluntary statement form, see attached.

On July 27th 2023, I made telephone contact with Corey. Just like Vittoria, Corey explained his dating relationship with her had extended into 2019, at which time they separated. After the separation, Corey took a job with Travel Land RV, where Vittoria works. Corey explained that he uncovered several different law violations that this company was doing and reported it all to LPD. Shortly after, Corey was terminated. Corey expressed his negative opinion of LPD and Nez Pierce County. Which may be a reason a link to these photos were put on the NPC Web Page.

I asked Corey if he knew anything about the explicit sexual photos of Vittoria that can be seen publicly. Corey did not act surprised at all and stated, "I don't know how those pictures would have got there, it wasn't me". I asked Corey, who else could it have been. Cory replied, "I got Asperger's , I don't care". Corey indicated, "Vittoria could have done all this herself, in order to frame me". Corey continued to deny all allegations of any wrong doing. I ended my conversation Corey and explained that I will be back in touch with him.

On August 1 2023, I received a copy of an email that was sent to Trae, from Cory. In this email, see attached, Cory admits to a previous charge of 3rd degree sexual Defamation. After conducting further research in Corey's III Sheet, I do see that Cory has a prior conviction of Criminal Defamation. It was also brought to my attention that Cory has a link to all of these sexual explicit photos on his own personal Face Book page for anyone to see.

On August 3, I spoke with Cory again. I did verify that this particular Face Book page belonged to him. I did verify that he did in fact post this specific link, and that the link goes directly to a Google file. Its within that file that holds the sexual explicit photographs of Vittoria Puccini. Cory denied knowing that these photos were in that file and explained that he was going to

remove the entire message and file.

Due to the fact that the photos were added into a file intended to basically harass other public officials, and not directed to Vittoria, I am not going to be able to prove that Corey knowingly placed these photos on social media to harass Vittoria. There are several steps that have to be taken to even get to these specific photos, and are in a file amongst several other files. At this time probable cause does not exist to charge Corey with a crime.

I VOLUNTEER THE FOLLOWING INFORMATION ON MY OWN FREE WILL FOR WHATEVER PURPOSE IT MAY SERVE:

1. Corey Michael Switzer was my boyfriend from Sept. 2018 through Oct. 2019. During that time he was emotionally, mentally and financially abusive and demanded to take sexually explicit photos of me which were meant to be kept private but he would occasionally send me through text messages. I explicitly did not give consent to post any of these images online. Recently he has posted these images to the Nez Perce county prosecutors facebook page publicly. They have my name attached to them, my previous name as I had a legal name change. My previous name was Meghan Joellen McGreary. Corey Switzer has also been stalking me online, he found my current boyfriend's facebook page and sent him sexually explicit photos of me to him on messenger. Unfortunately the messages were deleted so I have no physical proof at this time but I am trying to recover the messages.

I would like to have these images from the Nez Perce County prosecutor's facebook page to be taken down. His harassment of me has been ongoing.
