PLAINTIFF'S SUPPLEMENTAL NOTICE OF FILING –
CLAW-BACK DEMAND EMAIL (JUNE 9, 2026)

COMES NOW Plaintiff Corey Michael Switzer, pro se, and provides this Supplemental Notice of Filing to place into the record a document that is directly relevant to the issues of bad faith, waiver of attorney-client privilege, and the crime-fraud exception.

I. THE DOCUMENT

On June 9, 2026, Defendant's counsel, Amanda D. Daylong, sent an email to Plaintiff and numerous other recipients demanding that all parties delete the unredacted version of Exhibit P (the January 9, 2026 email in which Ms. Daylong proposed a "retroactive retainer agreement"). A true and correct copy of that claw-back demand email is attached hereto as **Exhibit 1**.

II. RELEVANCE TO PENDING PROCEEDINGS

This claw-back demand is highly relevant to the following issues:

1. **Bad Faith / Consciousness of Guilt.** The demand attempts to suppress evidence of a scheme to backdate public records and conceal the unlawful expenditure of public funds. The timing – immediately after Plaintiff filed the unredacted email with the Court – demonstrates that Defendant's counsel knew the document was damaging.
2. **Waiver of Attorney-Client Privilege.** The January 9, 2026 email was sent to non-attorneys Chris Kemp and Stacey Harman, and was produced as a public record request PDR26-10 in response to the SAO audit. The privilege, if any, was long waived. The claw-back demand does not revive it. *See Sanders v. State*, 169 Wn.2d 827 (2010); *Pappas v. Holloway*, 114 Wn.2d 198 (1990).
3. **Crime-Fraud Exception.** The underlying email discusses a scheme to create a retroactive paper trail to "clear" the County regarding expenditures of public funds. That is evidence of potential fraud, and the crime-fraud exception strips any claim of privilege. *Dietz v. Doe*, 131 Wn.2d 835 (1997).
4. **Spoliation and Ethical Violations.** Ms. Daylong's demand that all recipients delete the email after the Plaintiff had filed with this court – including non-parties and members of the media – raises serious concerns about witness intimidation and obstruction of justice. Plaintiff has not complied with the demand, and the document remains in the public record.

III. REQUEST

Plaintiff respectfully requests that the Court:

- Take judicial notice of this Supplemental Notice and Exhibit 1;
- Consider the claw-back demand as further evidence of Defendant's bad faith in determining statutory penalties under RCW 42.56.550(4) and the *Yousoufian* factors;
- Consider the claw-back demand as support for the crime-fraud exception to any claim of privilege over the withheld PDR 25-23 email; and
- Preserve this document as part of the record for all pending and future proceedings.

IV. DECLARATION

I, Corey Michael Switzer, declare under penalty of perjury under the laws of the State of Washington that the attached Exhibit 1 is a true and correct copy of the email sent by Amanda D. Daylong on June 9, 2026, as it appeared in my email account, and that I have not altered or modified the document in any way.
